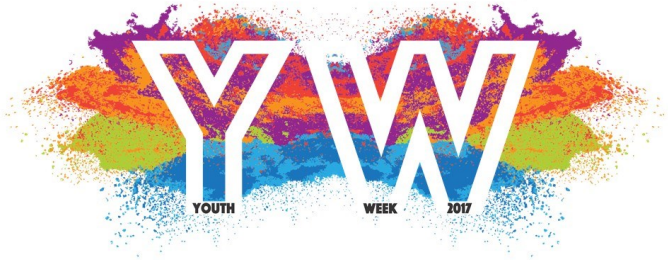

Participation Agreement:

I acknowledge that participation in the activity described above involves risk to the Participant (and to Participant's parents/guardians, if Participant is a minor), and may result in various types of injury including, but not limited to the following: sickness, bodily injury, death, emotional injury, personal injury, property damage and financial damage.

In consideration for the opportunity to participate in the Activity described above (the "Activity"), the Participant (or parent/guardian, if Participant is a minor) acknowledges and accepts the risks of injury associated with participation in and transportation to and from the Activity. The Participant (or parent/guardian) accepts personal financial responsibility for any injury or other loss sustained during the Activity or during transportation to and from the Activity, as well as for any medical treatment rendered to the Participant that is authorized by the Sponsor or its agents, employees, volunteers, or any other representatives (collectively referred to hereinafter as the "Activity Sponsor"). Further, the Participant (or parent/guardian) releases and promises to indemnify, defend, and hold harmless the Activity Sponsor for any injury arising directly or indirectly out of the described Activity or transportation to and from the Activity, whether such injury arises out of the negligence of the Activity Sponsor, the Participant, or otherwise.

If a dispute over this agreement or any claim for damages arises, the Participant (or parent/guardian) agrees to resolve the matter through a mutually acceptable alternative dispute resolution process. If the Participant (or parent/guardian) and the Activity Sponsor cannot agree upon such a process, the dispute will be submitted to a three-member arbitration panel for resolution pursuant to the rules of the American Arbitration Association.

- In the event of sickness or medical emergency where I am not present and cannot be reached, I request that my student participant receive any medical attention or treatment deemed necessary by the staff and/or ministry leadership of Harbor Churches. Therefore, I give permission to any hospital, doctor and/or healthcare provider to treat, transport/admit my participant. I grant permission for the release of medical records in the case of accident during an activity. I understand that I am responsible for all expenses and charges for the treatment and care of my child.
- The above named participant has my permission to travel in a Harbor Churches owned vehicle, a vehicle rented by Harbor Churches or a privately owned vehicle.
- I give permission for pictures, video, and/or audio of my child to be used on any Harbor Church website, social media, or other in-house publicity. If I am opposed to this I will request a denial form from a Harbor Churches staff member.
- Trained staff may administer over-the-counter medication if needed.
